Portfolio and Market Returns

The Bentham Global Income Fund had a total return (after fees) of 1.15% in the month of April, outperforming the benchmark (50% Bloomberg AusBond Bank Bill Index, 50% Bloomberg AusBond Composite Index) after fees by 0.92%. On a before fees basis the fund returned 1.21% for the month, outperforming the benchmark by 0.99%.

April was a strong month for markets after a brief set-back in March. Equities rallied with Australian and US government bonds slightly weaker. Concerns surrounding Brexit have been post-poned, while in the US economic data remains robust with US unemployment (3.6%) at multi-decade lows going back to the Vietnam war.

The top performing contributors to performance included Global Syndicated Loans, Bank Capital Securities and Global Hybrids; whilst the bottom performing contributors included Investment Grade Credit, Collateralised Loan Obligations (CLO) and European Convertibles.

Our outlook for global credit markets in 2019 remains cautiously optimistic even with the recent rebound. Over the medium term, we expect that the strong macroeconomic environment in the US will continue to be supportive of credit markets while our concerns about a tariff related slow-down in China and a knock-on effect for Australia remain elevated.

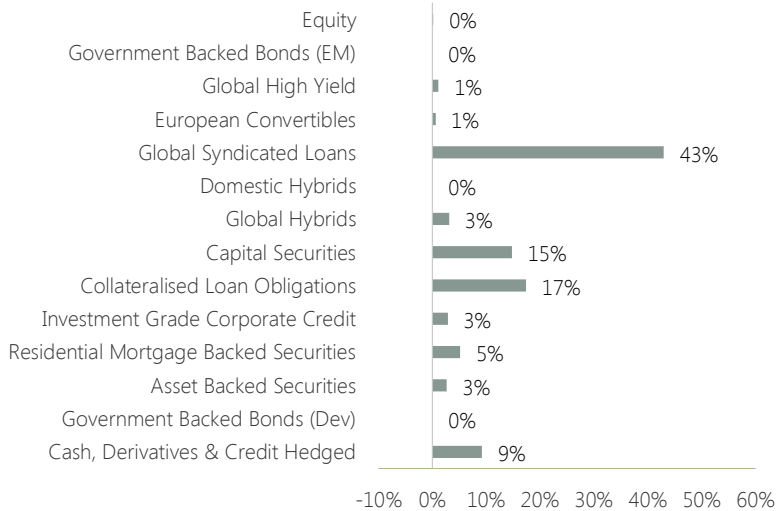
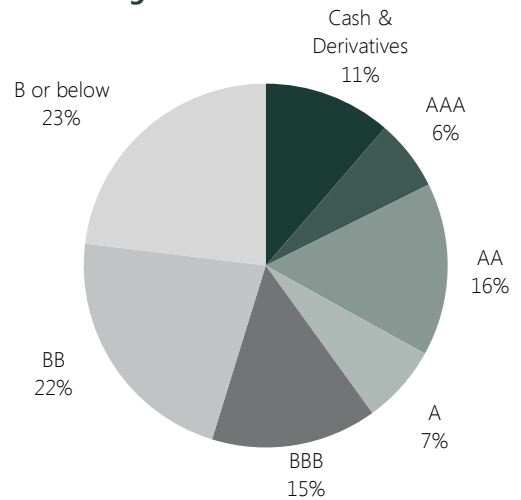
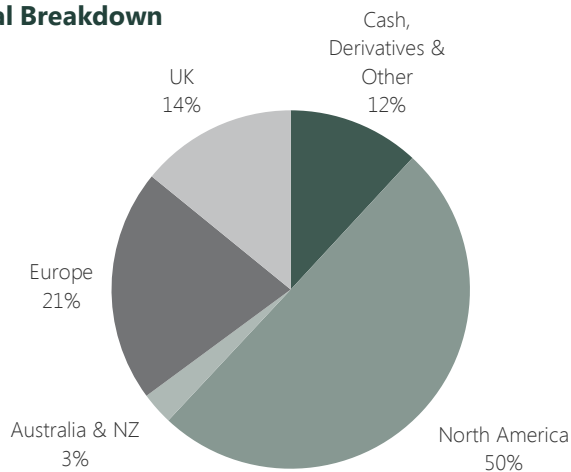
