Investment Objective

The Fund provides exposure to global credit markets and aims to generate income with some potential for capital growth over the medium to long term.

Portfolio and Market Returns

The Bentham Global Income Fund NZD had a total return (after fees) of -0.20% in the month of February, underperforming the benchmark (50% Bloomberg AusBond Bank Bill Index (hedged to NZD), 50% Bloomberg AusBond Composite Index (hedged to NZD)) by 0.70%. On a before fees basis the fund returned -0.14% for the month, underperforming the benchmark by 0.64%.

A Chinese flu epidemic turned into a likely global pandemic, led by South Korea, Italy and Iran. Voices of concern over Coronavirus dominated markets in February, and drowned out a chorus of historical but robust fundamental economic data and the end of the US impeachment drama.

The top contributors to performance included Collateralised Loan Obligations (CLO), Residential Mortgage Backed Securities (RMBS) and Investment Grade Credit; whilst the bottom performing contributors included Global Syndicated Loans, Asset Backed Securities (ABS) and Equity Securities.

Market volatility has increased post February month-end, as investors try to determine whether the Coronavirus impact will disrupt activity and profitability for one to two quarters or if they will impact markets for a more extended period of time.

Looking beyond the current volatility, we note that Credit is not dependant on high profit growth. It usually sits at the top of the capital structure, protected by equity/shares and secured by assets. Credit spreads continue to benefit from loose monetary policy and protections of the business cycle. The starting point for government bond yields is low and below the current inflation rate. Credit spreads will likely provide an increasingly important way of achieving a positive real return, in a potentially low return environment. Still on the horizon is the November US election. With centrist Biden now the presumptive DNC nominee, markets are potentially able to discount more progressive changes for the foreseeable future.

The current distribution rate setting was based on the running yield of the Fund as at 30 June 2019 and assumes the Fund continues to achieve an equivalent yield for FY2020. Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.

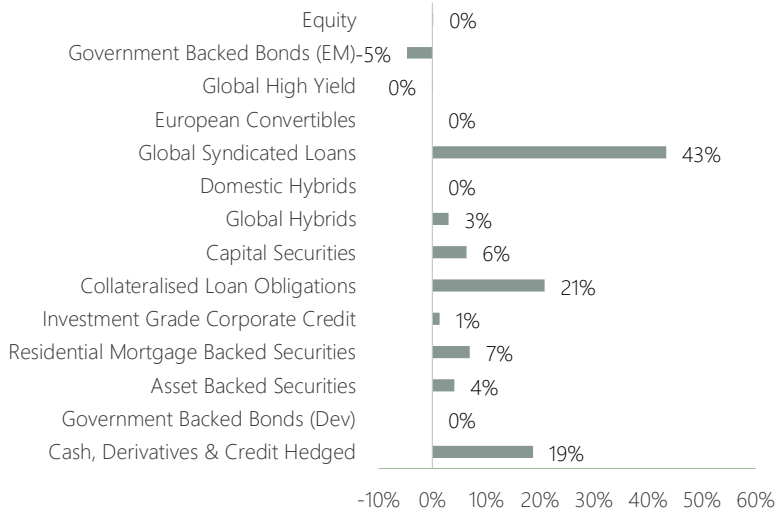
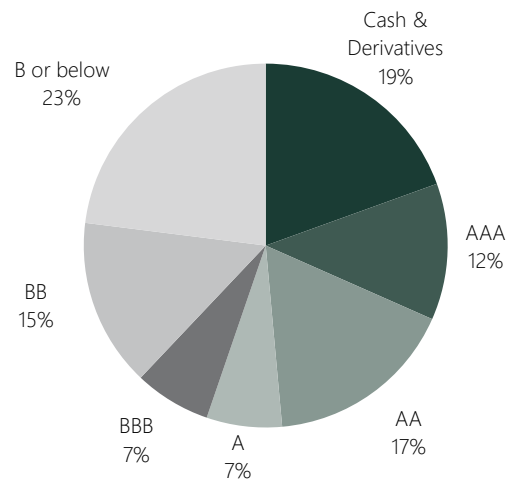
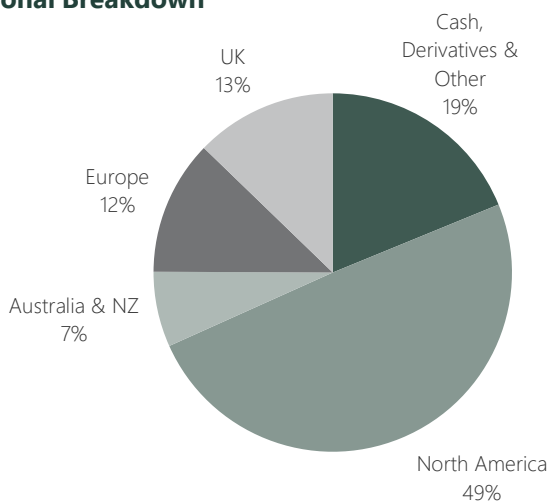
