## **Fund Aim**

## **Portfolio and Market Returns**

The Bentham High Yield Fund had a total return (after fees) of -0.39% in the month of September, outperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index<sup>3</sup> (hedged into AUD) by 0.69%. On a before fees basis the fund returned -0.36% for the month, outperforming the benchmark by 0.72%.

## **High Yield Market**

For the month, 5 of the 23 industries had positive returns. The top performing industries in September were Retail, Aerospace and Metals/Minerals with returns (sector performance in USD terms) of 1.35%, 1.01% and 0.19% respectively. The worst performing industries were Energy, Broadcasting and Cable/Wireless Video with returns of -3.07%, -2.18% and -1.35% respectively.

The credit yield spread for the Index increased by 39 bps during the month to 539 bps.

## **Portfolio Exposures**

The Fund's three largest industry exposures are 11.0% in Buildings and Real Estate, 8.3% in Electronics and 7.7% in Diversified/Conglomerate Service. The Fund's top three company exposures are 1.2% in Altice, 1.1% in Vertical and 1.0% in Avantor. During the month, the Fund increased its exposure to Sprint Communications, GCI and Lorca Telecom; with decreased exposures to Spirit AeroSystems, Delta Air Lines and Bausch Health.


