

## Bentham Global Opportunities Fund

#### **Fund Aim**

To provide diversified exposure to securities across global credit markets, with the flexibility to adapt its credit and cash exposure to suit market conditions across the credit cycle, and deliver consistent levels of income.

### **Portfolio and Market Returns**

The Bentham Global Opportunities Fund had a before fees return of -2.48% for the month, underperforming the benchmark by 2.53%. The top performing contributors to performance included Residential Mortgage Backed Securities (RMBS), Asset Backed Securities (ABS) and Convertibles; whilst the bottom performing contributors included Global Syndicated Loans, Capital Securities and Global Hybrids.

#### **Portfolio Asset Allocation**

During the month, exposures to Cash, Government Backed Bonds (Emerging Market) and Collateralised Loan Obligations increased, whilst exposures to Global Syndicated Loans, Investment Grade Corporate Credit and Capital Securities decreased. Current asset allocations are 53.6% in Global Syndicated Loans, 7.9% in Global High Yield, 6.8% in Capital Securities, 6.4% in Investment Grade Corporate Credit, 4.1% in Collateralised Loan Obligations, 2.0% in Global Hybrids, 1.6% in Asset Backed Securities, 0.7% in Equity, 0.3% in Residential Mortgage Backed Securities, 0.1% in Convertibles, -1.9% in Government Backed Bonds (EM) and 18.4% in Cash, Derivatives & Credit Hedges.

#### **Portfolio Industry and Issuer Exposures**

The Fund's largest industry exposures are: 9.9% in Electronics, 8.7% in Aerospace and Defense and 8.6% in Banking. The Fund's top three company exposures are: 2.0% in Qantas Airways Ltd, 1.6% in Heathrow Funding Ltd and 1.4% in Cooperatieve Rabobank UA.

#### Leveraged Loan Market

The top performing leveraged loan industries in June were Energy, Utility and Metals/Minerals with returns (sector performance in USD terms) of -0.55%, -0.55% and -1.17% respectively. The worst performing loan industries were Housing, Gaming/Leisure and Information Technology with returns of -2.96%, -2.66% and -2.43% respectively.





#### **Portfolio Asset Allocation**








