

Bentham Asset Backed Securities Fund

Investment Objective

To provide exposure to investment grade global asset backed securities (ABS) and generate stable income with some capital growth.

Portfolio Returns

The Bentham Asset Backed Securities Fund had a total return (after fees) of -1.54% in the month of April, underperforming the benchmark (Bloomberg AusBond Bank Bill Index) by 1.89%. On a before fees basis the fund returned -1.51% for the month, underperforming the benchmark by 1.86%.

Portfolio Exposures

The Fund's sector allocations are 26.8% in Australian Residential Mortgage Backed Securities (RMBS), 20.8% in European Collateralised Loan Obligations (CLO), 20.1% in US Broadly Syndicated CLO, 14.5% in Cash & Derivatives, 7.0% in Middle Market CLO, 6.8% in UK RMBS, 2.1% in Credit Card ABS, 1.2% in Aircraft ABS, 0.3% in European RMBS, 0.3% in US Commercial Real Estate (CRE), 0.0% in Personal Loan ABS and 0.0% in Auto ABS.

Contributors

The top performing contributors to performance included European CLO and US Broadly Syndicated CLO; whilst the bottom performing contributors included European RMBS and US CRE. The Fund's long interest rate duration positioning detracted from performance in April.

Outlook

The Fund remains focused on the higher rated tranches of ABS issuance, offering investors a high credit quality, higher yielding, secured alternatives to investment grade corporate and government bonds.

We place a high value on the structural benefits ("terms") typically included in global ABS structures to help preserve the principal of investors in the higher-rated tranches, such as cashflow priority, security, seniority, and reduction in leverage over time.




