

## Bentham Global Income Fund NZD

April 2024

## **Investment Objective**

The Fund provides exposure to global credit markets and aims to generate income with some potential for capital growth over the medium to long term.

#### **Portfolio and Market Returns**

The Bentham Global Income Fund NZD had a total return (after fees) of -1.86% in the month of April, underperforming the benchmark (50% Bloomberg AusBond Bank Bill Index (hedged to NZD), 50% Bloomberg AusBond Composite Index (hedged to NZD)) by 1.16%. On a before fees basis the fund returned -1.80% for the month, underperforming the benchmark by 1.10%.

Investments markets were weaker in April as expectations for rate cuts were pushed out on sticky inflation and resilient economic data. Equity and fixed income markets were lower (yields higher), while Emerging Market equities registered small gains, led by China.

The top contributors to performance included Collateralised Loan Obligations (CLO), Residential Mortgage Backed Securities (RMBS) and Bond; whilst the bottom performing contributors included Investment Grade Credit, Capital Securities and Global Syndicated Loans. The Fund's long interest rate duration positioning detracted from performance in April.

Investment markets are pricing in both a rate cutting cycle starting later this year and a continuation of positive earnings growth from companies. While cash rates are now on hold in most G10 countries, monetary policies are currently quite restrictive. We remain cautious on the investment return outlook as we believe the market may be underestimating the economic risk from the lagged impact of recent cash rate hikes.







### **Portfolio Asset Allocation**






## **Credit Rating Breakdown**
