Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of -0.93% in the month of April, outperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index³ (hedged into AUD) by 0.17%. On a before fees basis the fund returned -0.87% for the month, outperforming the benchmark by 0.22%.

High Yield Market

For the month, none of the 23 industries had positive returns. The top performing industries in April were Aerospace, Energy and Metals/Minerals with returns (sector performance in USD terms) of -0.07%, -0.35% and -0.36% respectively. The worst performing industries were Broadcasting, Cable/Wireless Video and Telecommunications with returns of -2.85%, -2.69% and -1.87% respectively.

The credit yield spread for the Index increased by 3 bps during the month to 311 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 9.2% in Diversified/Conglomerate Service, 7.9% in Finance and 6.9% in Electronics. The Fund's top three company exposures are 1.3% in Altice Financing, 1.1% in Mozart Debt Merger Sub and 1.1% in HealthEquity. During the month, the Fund increased its exposure to Vail Resorts, Taseko Mines and Alliant Holdings Intermediate LLC Alliant Holdings Co-Issuer; with decreased exposures to National Financial Partners, Valvoline and Ati.






Portfolio Asset Allocation



Regional Breakdown




High Yield Spread to Worst (bps)
