

## Bentham Syndicated Loan Fund NZD

### **Fund Aim**

To provide investors with a diversified exposure to the global syndicated loan market with an active allocation to investments in different industries, issuers and geographies.

#### **Portfolio and Market Returns**

The Bentham Syndicated Loan Fund NZD had a total return (after fees) of 0.23% in the month of April, underperforming the benchmark (Credit Suisse Leveraged Loan Index hedged into NZD) by 0.46%. On a before fees basis the fund returned 0.30% for the month, underperforming the benchmark by 0.40%.

#### **Fund Statistics**

At month end, the Fund had a yield to maturity of 9.96% and running yield of 9.27%, with the credit yield spread increasing by 2 bps to 465 bps during the month. The Fund had an interest rate duration of 0.43 years and credit duration of 2.94 years.

#### Leveraged Loan Market

The discount margin (3 year) for the Index decreased by 4 bps during the month to 504 bps.

The top performing leveraged loan industries in April were Metals/Minerals, Consumer Durables and Manufacturing with returns (sector performance in USD terms) of 1.14%, 1.09% and 0.99% respectively. The worst performing loan industries were Media/Telecommunications, Consumer Non-Durables and Chemicals with returns of 0.12%, 0.53% and 0.54% respectively.

#### **Portfolio Exposures**

The Fund's three largest industry exposures are 14.8% in Electronics, 9.2% in Diversified/Conglomerate Service and 8.7% in Healthcare, Education and Childcare. The Fund's top three company exposures are 1.3% in Ukg, 1.2% in Polaris Newco and 1.0% in Assuredpartners. During the month, the Fund increased its exposure to AssuredPartners, Genesee & Wyoming and Cast & Crew; with decreased exposures to Entegris, GEMS MENASA Cayman Ltd GEMS Education Delaware and Ziggo Financing Partnership.

The current distribution rate setting was based on the running yield of the Fund as at 30 June 2023 and assumes the Fund continues to achieve an equivalent yield for FY2024. Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.




#### **Discount Margin and Average Price of US Loan Market**
