Portfolio Returns

The Bentham Asset Backed Securities Fund had a total return (after fees) of 0.60% in the month of May, outperforming the benchmark (Bloomberg AusBond Bank Bill Index) by 0.23%. On a before fees basis the fund returned 0.63% for the month, outperforming the benchmark by 0.26%.

Portfolio Exposures

The Fund's sector allocations are 30.8% in Australian Residential Mortgage Backed Securities (RMBS), 20.6% in European Collateralised Loan Obligations (CLO), 20.3% in US Broadly Syndicated CLO, 11.0% in Cash & Derivatives, 6.8% in Middle Market CLO, 6.5% in UK RMBS, 2.1% in Credit Card ABS, 1.2% in Aircraft ABS, 0.3% in European RMBS, 0.3% in US Commercial Real Estate (CRE), 0.0% in Personal Loan ABS and 0.0% in Auto ABS.

Contributors

The top performing contributors to performance included US Broadly Syndicated CLO and European CLO; whilst the bottom performing contributors included European RMBS and US CRE.

Outlook

The Fund remains focused on the higher rated tranches of ABS issuance, offering investors a high credit quality, higher yielding, secured alternatives to investment grade corporate and government bonds.

We place a high value on the structural benefits ("terms") typically included in global ABS structures to help preserve the principal of investors in the higher-rated tranches, such as cashflow priority, security, seniority, and reduction in leverage over time.






