Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of 1.16% in the month of May, outperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index³ (hedged into AUD) by 0.18%. On a before fees basis the fund returned 1.22% for the month, outperforming the benchmark by 0.24%.

High Yield Market

For the month, 21 of the 23 industries had positive returns. The top performing industries in May were Food And Drug, Wireless Communications and Utility with returns (sector performance in USD terms) of 2.08%, 1.90% and 1.65% respectively. The worst performing industries were Broadcasting, Telecommunications and Cable/Wireless Video with returns of -3.03%, -0.28% and 0.17% respectively.

The credit yield spread for the Index increased by 3 bps during the month to 314 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 9.8% in Diversified/Conglomerate Service, 9.4% in Electronics and 7.0% in Finance. The Fund's top three company exposures are 1.2% in Open Text, 1.1% in Cqp Holdco Lp Bip-v Chinook and 1.1% in Altice Financing. During the month, the Fund increased its exposure to Epicor Software, BC Equity Ventures and Lti; with decreased exposures to Masonite International, SunCoke Energy and Interface.

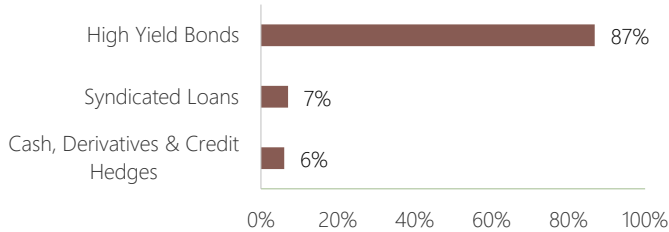

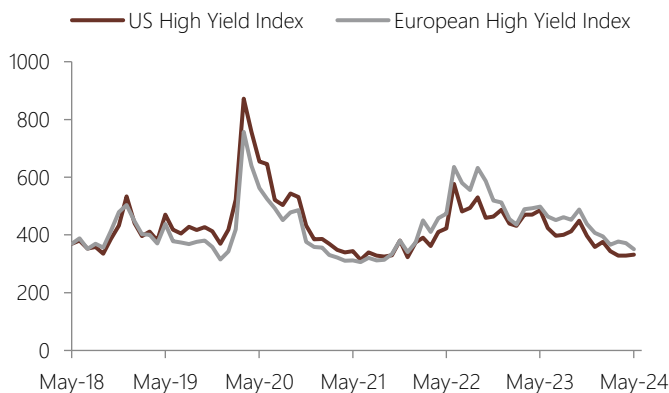
