Portfolio and Market Returns

The Bentham Syndicated Loan Fund NZD had a total return (after fees) of 1.09% in the month of May, outperforming the benchmark (Credit Suisse Leveraged Loan Index hedged into NZD) by 0.20%. On a before fees basis the fund returned 1.16% for the month, outperforming the benchmark by 0.28%.

Fund Statistics

At month end, the Fund had a yield to maturity of 9.47% and running yield of 8.96%, with the credit yield spread decreasing by 39 bps to 426 bps during the month. The Fund had an interest rate duration of 0.40 years and credit duration of 2.83 years.

Leveraged Loan Market

The discount margin (3 year) for the Index decreased by 13 bps during the month to 492 bps.

The top performing leveraged loan industries in May were Chemicals, Healthcare and Financial with returns (sector performance in USD terms) of 1.50%, 1.41% and 1.21% respectively. The worst performing loan industries were Media/Telecommunications, Manufacturing and Housing with returns of 0.21%, 0.43% and 0.57% respectively.

Portfolio Exposures

The Fund's three largest industry exposures are 13.5% in Electronics, 9.6% in Diversified/Conglomerate Service and 7.9% in Healthcare, Education and Childcare. The Fund's top three company exposures are 1.2% in Polaris Newco, 0.9% in Assuredpartners and 0.8% in Ukg. During the month, the Fund increased its exposure to Epicor Software, Presidio and TricorBraun; with decreased exposures to Open Text, Ukg and Ultimate Software Group Inc.

The current distribution rate setting was based on the running yield of the Fund as at 30 June 2023 and assumes the Fund continues to achieve an equivalent yield for FY2024. Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.

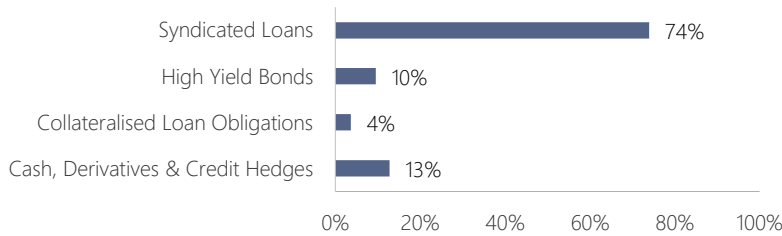
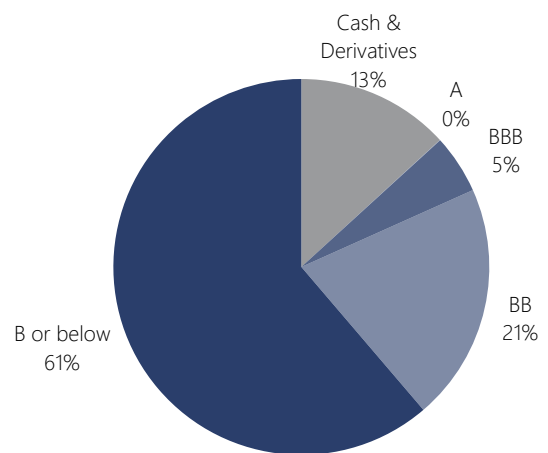

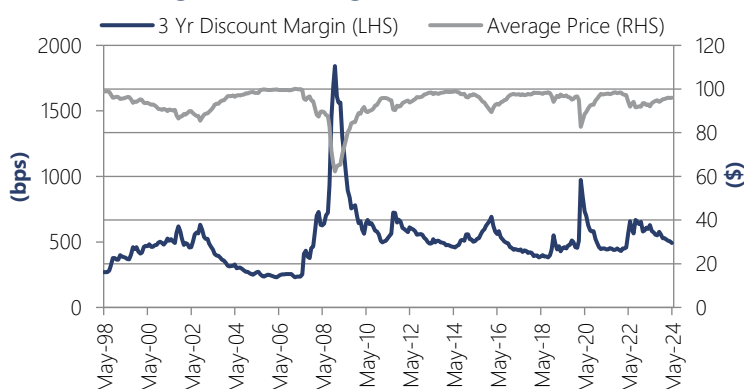
