Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of 0.57% in the month of September, underperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index3 (hedged into AUD) by 0.94%. On a before fees basis the fund returned 0.62% for the month, underperforming the benchmark by 0.89%.

High Yield Market

For the month, 22 of the 23 industries had positive returns. The top performing industries in September were Cable/Wireless Video, Broadcasting and Forest Prod/Containers with returns (sector performance in USD terms) of 5.58%, 4.14% and 2.11% respectively. The worst performing industries were Energy, Food And Drug and Transportation with returns of -0.22%, 0.89% and 0.95% respectively.

The credit yield spread for the Index decreased by 11 bps during the month to 301 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 10.0% in Diversified/Conglomerate Service, 8.6% in Electronics and 7.1% in Oil and Gas. The Fund's top three company exposures are 1.2% in Open Text, 1.1% in Standard Industries Inc and 1.1% in Cqp Holdco Lp Bip-v Chinook. During the month, the Fund increased its exposure to Focus Financial Partners, Tronox and Speedway Motorsports LLC; with decreased exposures to Sonic Automotive, Camelot Return Merger Sub and GFL Environmental.

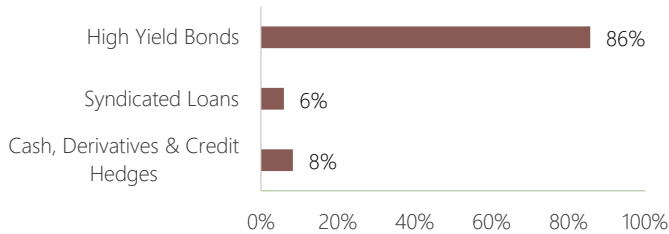

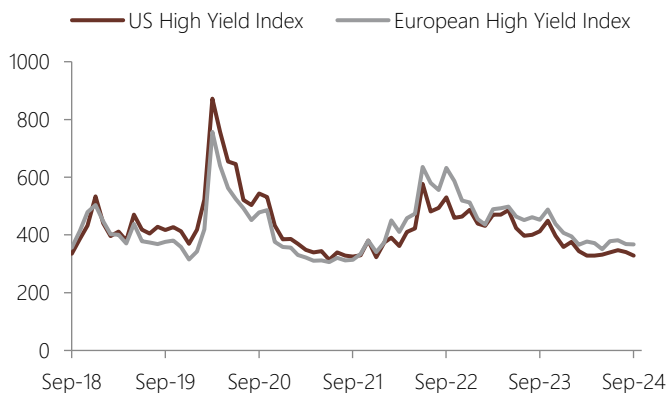
