Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of -0.24% in the month of December, outperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index³ (hedged into AUD) by 0.22%. On a before fees basis the fund returned -0.19% for the month, outperforming the benchmark by 0.28%.

High Yield Market

For the month, 3 of the 23 industries had positive returns. The top performing industries in December were Broadcasting, Forest Prod/Containers and Transportation with returns (sector performance in USD terms) of 0.86%, 0.15% and 0.02% respectively. The worst performing industries were Cable/Wireless Video, Utility and Housing with returns of -0.84%, -0.77% and -0.74% respectively.

Portfolio Exposures

The Fund's three largest industry exposures are 9.3% in Diversified/Conglomerate Service, 9.1% in Electronics and 8.3% in Buildings and Real Estate. The Fund's top three company exposures are 1.2% in Cqp Holdco Lp / Bip-v Chinook Holdco Llc, 1.2% in Jane Street Group LLC and 1.0% in Arcosa Inc. During the month, the Fund increased its exposure to Focus Financial Partners, Tronox and Speedway Motorsports LLC; with decreased exposures to Sonic Automotive, Camelot Return Merger Sub and GFL Environmental.

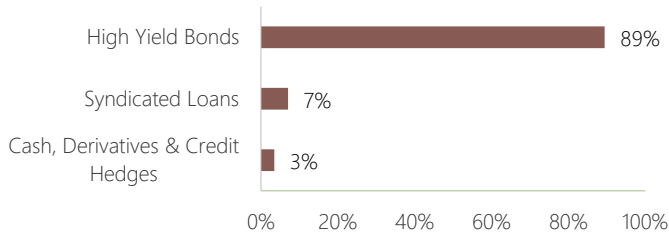

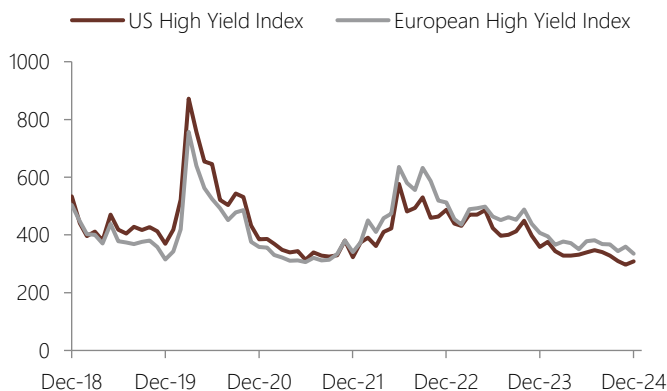
