Investment Objective

To provide exposure to investment grade global asset backed securities (ABS) and generate stable income with some capital growth.

Portfolio Returns

The Bentham Asset Backed Securities Fund had a total return (after fees) of 0.91% in the month of February, outperforming the benchmark (Bloomberg AusBond Bank Bill Index) by 0.57%. On a before fees basis the fund returned 0.94% for the month, outperforming the benchmark by 0.60%.

Portfolio Exposures

The Fund's sector allocations are 43.4% in Australian Residential Mortgage Backed Securities (RMBS), 18.7% in European Collateralised Loan Obligations (CLO), 15.0% in Cash & Derivatives, 13.3% in US Broadly Syndicated CLO, 5.5% in UK RMBS, 1.6% in Middle Market CLO, 1.5% in Credit Card ABS, 0.3% in Aircraft ABS, 0.0% in US Commercial Real Estate (CRE), 0.0% in Auto ABS, 0.0% in Personal Loan ABS and 0.0% in European RMBS.

Outlook

The Fund remains focused on the higher rated tranches of ABS issuance, offering investors a high credit quality, higher yielding, secured alternatives to investment grade corporate and government bonds, with low interest rate risk.

We place a high value on the structural benefits ("terms") typically included in global ABS structures to help preserve the principal of investors in the higher-rated tranches, such as cashflow priority, security, seniority, and reduction in leverage over time.






