

**Bentham Global Income Fund NZD**
**October 2024**
**Investment Objective**

The Fund provides exposure to global credit markets and aims to generate income with some potential for capital growth over the medium to long term.

**Portfolio and Market Returns**

The Bentham Global Income Fund NZD had a total return (after fees) of -1.90% in the month of October, underperforming the benchmark (50% Bloomberg AusBond Bank Bill Index (hedged to NZD), 50% Bloomberg AusBond Composite Index (hedged to NZD)) by 1.17%. On a before fees basis the fund returned -1.83% for the month, underperforming the benchmark by 1.10%.

Investment markets were mixed in October, with US equities and fixed-income markets weaker but credit markets outperforming, with spreads tighter across the board. Stronger-than-expected US economic data and a favourable Q3 earnings season led to a rethink on Fed rate cuts as Trump's election odds improved, which were seen as inflationary. US 10-year yields rose by 50 basis points to 4.28%.

In the UK, finance minister Rachel Reeves announced the largest tax increases since 1993, while the European Central Bank cut interest rates by 25 basis points. Chinese markets declined despite government stimulus.

In Australia, CPI returned to the RBA's target at 2.8% y/y, with the trimmed mean slightly higher at 3.5% y/y, though the data was influenced by government subsidies. The RBA held rates steady at 4.35% in its November meeting.

The top contributors to performance included Global Syndicated Loans, Collateralised Loan Obligations (CLO) and Residential Mortgage Backed Securities (RMBS); whilst the bottom performing contributors included Investment Grade Credit, Asset Backed Securities (ABS) and Capital Securities.

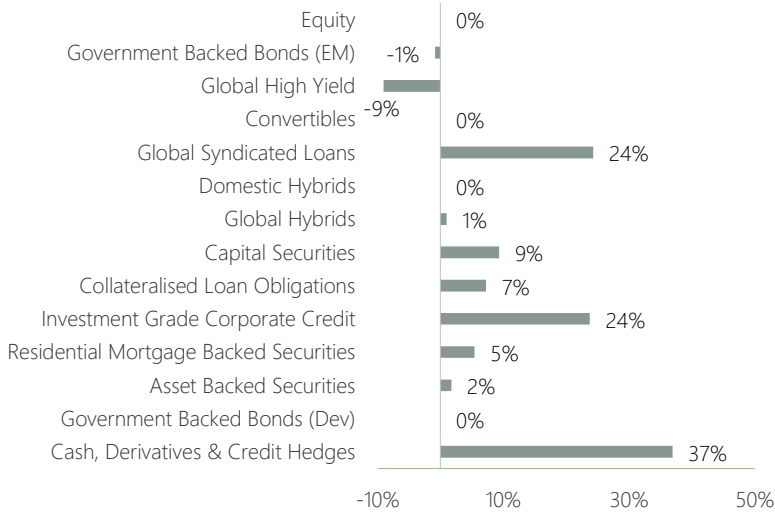
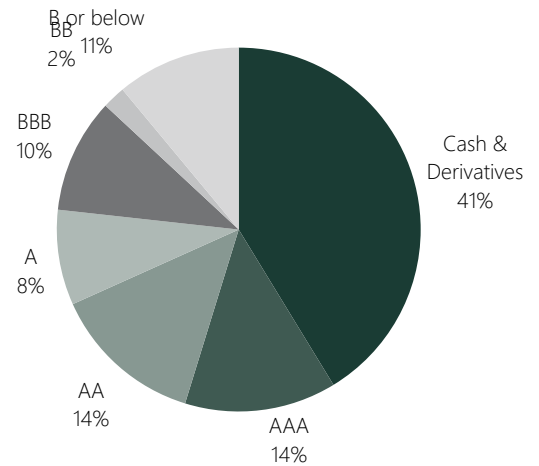
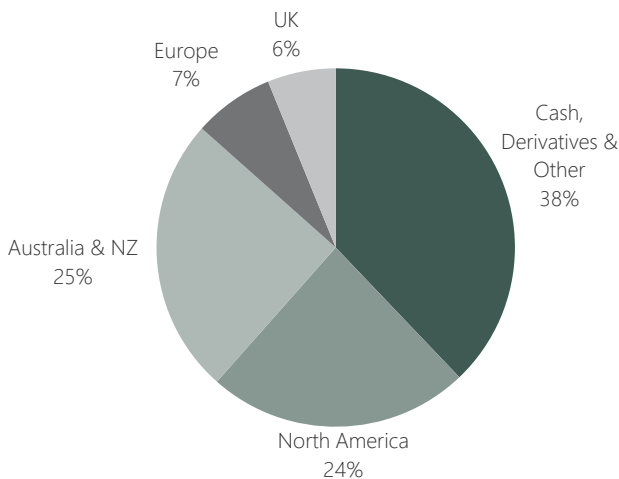
